

Guidelines for International Clients

- Fill out the required information in the Card-Scan application and the fingerprint form, and print them on a regular paper.
- Get your fingerprints taken on the fingerprint form (or a form having similar layout of fingerprints) by your local police. The name and address of the police office need to be mentioned on the fingerprint form, and the officer taking fingerprints needs to sign this form.
- Complete Third Party Consent form only if you are requesting the RCMP to send the Certified Criminal Record Check to Worldwide Forensic Services Inc., a lawyer, friend or family member. Otherwise, the RCMP will send the results to you via regular (non-trackable) mail.
- Include clear photocopies of two government issued identification documents (IDs). One must be a photo ID, with clearly visible photo.
- Send one passport style photograph (any size, front profile, without glasses and with neutral expressions).
- Complete the credit card payment form. If you want to pay via PayPal, please send us a quick email and we will send you a PayPal invoice.
- Send all the completed documents via mail (not-email) or courier to our Card Scan facility, to the address on the check-list. We cannot process scanned copies.
- We will digitize inked fingerprints to encrypted format and transmit them to the RCMP (via a secure server).
- The RCMP will send the certified criminal record check (hard copy) via regular mail. The RCMP do not send the certificate via email or courier.
- In case you need it urgently, the RCMP can send it us and we can
 then forward it to you or a third party, via courier, at an additional
 cost. Please send us an email and provide your complete address to
 obtain a quote from the courier company.

*If the applicant was ever charged by the police in Canada, overstayed in Canada or deported from Canada, the RCMP can take up to 120 days or more to send the results.



Frequently Asked Questions

Can I email you a scanned version of my fingerprints for electronic transmission to the RCMP?

Unfortunately we cannot process scanned version of fingerprints. You would need to send us the original fingerprint form and the other documents, as per the check list, via mail or courier.

How would I know that you have received my documents?

Once we receive your documents and transmit fingerprints to the RCMP, we will send you a confirmation email. There is no need to keep on sending emails to check as to whether we have received your documents or not.

Can I get my fingerprints taken on the form used by the police of the country, I am living in?

Yes you can. Please make sure the fingerprint layout on that form is the same as on the RCMP's form or the FBI's fingerprint card. Please have a look on the sample fingerprint form.

Can RCMP send the Certified Criminal Record Check outside of Canada?

Yes (via regular mail), at no additional cost.

The Certified Criminal Record Check issued by the RCMP needs to be authenticated and legalized by an Embassy/Consulate in Canada. Do you also offer this service?

Yes we also offer this service at an additional fee. Please let us know your requirement and we will send you a price quote.

I need the Certified Criminal Record Check as soon as possible. Can I request the RCMP to send it to your company and you can then forward to me via courier?

Yes you can. Please send us a quick email providing your complete address. We will obtain a quote from the courier company and let you know. You would need to send a third party consent form.

Why do you ask for a photograph?

The photograph is printed on the certified criminal record check. We transmit photograph, along with the fingerprints, to the RCMP.

How can I pay for your services?

You can pay by a Credit Card (Visa or Master Card only), PayPal, an International Money Order or Email transfer. If you want to pay via PayPal, send us a quick message to request a PayPal invoice.

Can my friend or relative pay on my behalf?

Yes they can. You can forward credit card payment form to your friend or family member. They can complete it, sign it and email to us.

How can I check the status of my application?

Once we receive your documents and transmit fingerprints to the RCMP, we will send you a confirmation email. Unless authorized by the applicant, the RCMP do not release any further information to Worldwide Forensic Services Inc. The applicant or an authorized third party can inquire about the status of finger-prints submission by sending an email to the RCMP at ccrtis-scictr@rcmp-grc.gc.ca.

Can I print the fingerprint form emailed by you and get my fingerprints taken on it?

Yes you can.

I have a photocopy of fingerprint form. Can I send it to you for processing?

We cannot process photocopy. You need to send us the original fingerprint form via mail or courier.

Can RCMP send my Certified Criminal Record Check to my lawyer, immigration office or a third party?

Yes it is possible. You need to complete a third party consent form and write their address on it.
